

Candidates Respond to CAPE Public Education Principles Questionnaire

CAPE Ohio asked Central Ohio, State of Ohio, and Ohio Congressional District candidates who are running for office in the general election in November, 2018 to complete a questionnaire on public education. On the questionnaire candidates were asked which of the 13 Principles of the CAPE Ohio Vision for Public Education (see below) are consistent with their views and provided space for comments.

CAPE Ohio Principles for Public Education Provide Vision for Public Education

1. **Free, universal, high-quality public education** is a fundamental right of all children and adolescents in the United States – from early childhood through college.
2. **Public education must remain an institution for the public good** that ensures the betterment of all citizens. It is not a collection of investment opportunities and competitive markets. Teaching is a human profession, not a factory turning out workers and consumers.
3. **Public education must have visionary leadership.** Leaders – students, teachers, parents, administrators, and public officials – must proceed from a vision and purpose that are well understood and embraced by all participants in the system to which they are responsible.
4. **Equity and sufficiency in state and federal funding for public education must be addressed in order to meet the imperative to provide high-quality education for all.** The source of funding for insuring free, universal, and accessible high-quality education must be equitable and sufficient and, therefore, cannot rely on local/state property taxes.
5. **Responsible school and program choices must be offered within public education.** Parents and students must have free and open access to options and alternatives that do not, however, disadvantage other students or programs within the system.
6. **Twenty-First Century learning environments must be designed to grow potential in every student.** Everyone with whom students interact in a public school setting must help students develop their identities as positive and productive assets, constantly open to new learning. Intelligence is not set at birth, but grows and develops over time. Helping each student develop into a resilient, intelligent, resourceful, ethical, and compassionate human being is a

- more important goal than raising test scores or standardizing curriculum content.
7. **Curriculum in public schools must prepare students for a future of complexity and accelerating change.** School curriculum should be infused with the kind of creativity, engagement, and experimentation that preserves the human spirit and teaches students how to anticipate and meet future challenges. Public education must also help students grow their intelligence by developing habits of deep thinking, analytical skills, decision-making skills, and enduring understandings. Curriculum content should reflect agreed-upon learning outcomes.
 8. **Assessment practices must support optimal progress for all students** by collecting and studying evidence of learning in its many forms and using that evidence to make decisions about future learning needs. Moreover, assessments must be designed in ways to assist students in their pursuit of divergent interests.
 9. **The public's right to understand and guide the education system must be reflected in reasonable accountability methods.** These methods should address the responsibilities and impact of all components and participants in the public education system, including students, parents, teachers, administrators, schools, school boards, districts, communities, state education agencies, state and federal legislatures.
 10. **Teachers must be thoughtfully educated, highly regarded, valued, and respected members of a professional community** and compensated commensurate with their responsibilities, preparation, experience, and accomplishments.
 11. **Teacher preparation programs must be designed as clinically based models** of collaboration between teacher education and public pre K-12 institutions.
 12. **Vision and purpose should inform the kind of learning in which education professionals engage.** The shared vision, purpose, and identity of each school, district, or learning organization must guide its professional development efforts.
 13. Public education must identify and nurture the innovation and creativity that occur naturally within any complex organization in order to meet the evolving needs of students and families in a rapidly changing world.

Questionnaire Results

Names and offices sought are listed below along with the survey results from each candidate. Comments, if included by the candidate, are reprinted under the candidate's name. Most respondents who completed the questionnaire checked that all 13

principles are consistent with their own views on public education, but some candidates did not find that their own views were aligned with some of the CAPE Ohio principles.

Comments from Candidates for State of Ohio Offices

Governor

Richard Cordray, Democratic Candidate

Comments about the CAPE Ohio principles:

Principle 1 on free public education from early childhood through college:

The statement is consistent with my views on primary and secondary education.

Principle 4 on school funding:

As a lawyer who has long practiced and taught constitutional law, I believe the General Assembly must start following the law. Twenty-seven years ago, my friend Bill Phillis and the Ohio Coalition for Equity & Adequacy of School Funding stood up for Ohio's students and filed a historic lawsuit. Twenty-one years ago, the Ohio Supreme Court first declared that Ohio's school funding system was unconstitutional. The Court ruled for the plaintiffs three more times, but the legislature has yet to comply with the Court's orders. We have made considerable progress on part of the problem – improving facilities around the state – but the operational funding has never followed.

As governor, I will relentlessly press for a school funding system that is fair as well as “thorough and efficient” under the Ohio Constitution. The quality of a child's education should not be determined by their zip code. With your help, I will work with the legislature to deliver this needed change and to end residual budgeting for Ohio schools. I will also work to fulfill the commitment that Ohio made to secure broadband access throughout the state, the lack of which has exacerbated the inequities in the current educational program.

Additional information for voters regarding the candidate's vision for public education:

As mentioned above, Betty [Betty Sutton, lieutenant governor candidate] and I will reform the way in which we fund Ohio's public schools. We will limit and refocus classroom testing on what matters most for students, with input from teachers. We will recreate an evaluation system that is fair to teachers and schools. And we will hold all charter schools accountable for their performance and for the effective use of public

funds – including the closing of failing charters. In addition, the grotesque ECOT scandal demands civil and political – and if appropriate, criminal – accountability, We will do everything possible to recover these taxpayer funds, bring justice to those responsible, and reform state law to prevent this sort of taxpayer and student abuse from ever happening again.

Constance Gadell-Newton, Green Party Candidate

All 13 CAPE Ohio principles are consistent with the candidate’s views on public education.

Comments about the CAPE Ohio principles:

Thank you for your work in this area. You have done a nice job of laying out these principles. We want to increase the local government fund so all Ohio schools have adequate funding. We support public and community schools, as well as funding classrooms so teachers don’t have to. Public education needs to be a priority in Ohio!

State Auditor

Zack Space, Democratic Candidate

Comments about the CAPE Ohio principles:

I’m committed to holding all schools—for-profit charters in particular—accountable. I have announced my intentions to create a Special Audit Unit to audit attendance data of for-profit charter schools to determine how much taxpayer money was wasted in scams by schools such as the Electronic Classroom of Tomorrow (ECOT). The ECOT scandal is the biggest political scandal in Ohio history, and I will use the auditor’s office to prevent such a failure of oversight from happening once again.

Additional information for voters regarding the candidate’s vision for public education:

All Ohio children should have the opportunity to attend well-funded local schools. We should permit programs like post-secondary enrollment and open enrollment, for instance, where they make sense. The same goes for charter schools, provided they are held to the same standards as public schools.

It is past time for the Ohio general Assembly to find a solution to Ohio’s unconstitutional public funding system.
